CONTINUING EDUCATION SCHOLARSHIP APPLICATION**

**Participation Requirements:**

1. Participants must be enrolled or planning to enroll full or part-time in college or vocational school by Fall 2010.
2. Applicants must be from the Nolin RECC service area whose primary residence is in the Nolin service territory.
3. Previous scholarship winners, Nolin RECC employees, directors, or anyone receiving direct benefits from the co-op, and members of their immediate families, are not eligible for any scholarship awards.
4. One scholarship of \$1,000 will be awarded and must be used within two (2) years from the award date. The following reflects the judging criteria:

*Legitimate Financial Need (50%)                      Short Essay (25%)  
Community and Personal Achievement (25%)*

There is no age limit on the Continuing Education Scholarship. The short essay should be at least 500 words or less on why you should be awarded the \$1,000 scholarship.
